 - 2) Installation, maintenance, and removal of Depot Christmas Tree lighting, lighting supplies for seven oak trees surrounding Depot Christmas Tree, installation, maintenance, and removal of oak tree lighting estimate \$4,496.85. Cynthia Turner moved to approve bid with Board A paying ½. and Board B paying one-half. Katie Meeks 2nd, all in favor.

#4 Katie Meeks moved to approve, once verified this is installation, maintenance, and removal of existing downtown lights, \$1200.00. Cyndi Carlton 2nd, all in favor.

Payments begin on December 15th and are due on the 15th of each month until balance paid. He would like to pay \$1200.00 by November 15, 2024, and \$1000.00 per month thereafter until \$8200.00 is paid off. He can pay in full anytime. As part of the motion the Board will authorize Teresa Ballard to receive the payments.
